- [House Joint Resolution 16](#) allowing impeachment of statewide elected officials
- [House Bill 2004](#) establishing ranked choice voting for statewide offices, the President and members of Congress
- [Senate Joint Resolution 34](#) establishing an Independent Public Service Compensation Commission empowered to set pay for many elected officials
